Non-refundable check must accompany entry forms to secure a spot in the meet.  
Meet will have a 250-lifter capacity. Spots reserved via receipt of non-refundable check.  
Coaches may alter their roster as needed, but no refunds will be issued.
- ALL WAIVER AND ENTRY FORMS CAN BE DOWNLOADED OFF LHSPLA WEBSITE.**
- ENTRY FEE: **\$20.00 FOR EACH LIFTER** – Unlimited lifters per team.  
**MAKE ALL CHECKS PAYABLE TO: Abbeville High Powerlifting**
- ELIGIBILITY: Schools will be allowed to enter as many lifters as they wish. Any lifter, who meet the eligibility requirements set forth by the LHSPLA in Article VIII of the constitution, are eligible to lift.
- WAIVERS: All lifters participating in the Abbeville High School Invitational Meet must produce a signed waiver to be eligible to compete.
- UNIFORM: The LHSPLA uniform rule, Section III, rule 1 a-d, will be waived for all lifters.
- ADMISSION: Adults: \$7.00 (Children under school age get in free)
- AWARDS: Medals for 1<sup>st</sup>—3<sup>rd</sup> place finishers in each weight class.  
Outstanding Lifter awards for top light and heavy male and female.
