LIFTING SUITS AND SINGLETS ARE NOT REQUIRED.

WAIVERS:	All lifters participating in the WMHS Invitational Meet must produce a signed waiver to be eligible to compete.
UNIFORM:	The LHSPLA uniform rule, Section III, rule 1 a-d, will be waived for all lifters.
ADMISSION:	Adults: \$7, (Children under school age get in free)
AWARDS:	Trophies for 1 st —3 rd place finishers in each weight class. Outstanding Lifter Plaques: light and heavy platform-girls and boys.
CONCESSION:	No outside food or drink allowed
