1. Participation in LHSPLA/LHSAA powerlifting includes possible exposure to and illness from infectious diseases including, but not limited to, COVID-19. While particular rules, certification of sanitization of lifting areas by LHSPLA/LHSAA and personal discipline may reduce this risk, the risk of personal injury, illness, permanent disability and death does exist.

I acknowledge and understand as parent or legal guardian of the undersigned minor student athlete the contagious nature of COVID-19 including other infectious diseases and that he/she may be exposed to or infected by COVID-19 by participating in LHSPLA/LHSAA powerlifting. I understand and assume the risk of exposure to or infection by COVID-19 including other infectious diseases while engaged in LHSPLA/LHSAA powerlifting that may result from the actions, omissions, negligence or fault of LHSPLA/LHSAA, other participants, coaches, staff, LHSPLA Judges or administrative personnel at the lifting venue where the LHSPLA/LHSAA powerlifting meet is being held.
