

LHSPLA MEET SANCTIONING AGREEMENT – INVITATIONAL OR DUAL MEET

This agreement, made the _____ day of _____, 20____, by and between _____ High School and the Louisiana High School Powerlifting Association to acknowledge the sanctioning of the following Invitational

Powerlifting Meet: _____

A sanctioned invitational powerlifting meet is any powerlifting meet hosted by a member school that is contested between 3 or more member schools. Member schools hosting sanctioned invitational meets shall meet the criteria listed in Sections 8.01 and 8.02 in Article VIII in the LHSPLA Constitution.

Documentation about sanctioned invitational meets must be posted on the LHSPLA website and should include the following:

- 1) The host school and venue
- 2) The date and time of the meet
- 3) Entry information including entry submission forms, meet waivers, general meet information, entry fee costs and deadline dates for entry submission.

A dual powerlifting meet is any powerlifting meet hosted by a member school that is contested between two member schools. Member schools hosting sanctioned dual meets must meet the criteria listed in Sections 8.01 and 8.02 of Article VIII of the LHSPLA Constitution to allow them to host a dual powerlifting meet.

Documentation concerning sanctioned dual meets should be sent to the other member school involved and to the LHSPLA Executive Committee at least two weeks prior to the meet. This documentation should include:

- 1) The host school and venue
- 2) The Date and time of the meet
- 3) Entry information including entry submission forms, meet waivers, general meet information, entry fee costs and deadline dates for entry submission.

The LHSPLA will sanction the named meet listed above if the following criteria are met by the member school hosting said sanctioned invitational or dual meet:

- a) Have stated their intentions to host a sanctioned invitational meet and had it placed on the LHSPLA Meet Calendar by no later than the last Friday in October. Sanctioned dual meets do not have to be posted on the LHSPLA Meet calendar, but host schools must communicate the date and time of the meet with the LHSPLA Executive Committee at least two weeks before the dual meet is contested, meet the same criteria and follow the same procedures for a sanctioned invitational meet.
- b) Have paid the requisite \$100.00 sanctioning fee to the LHSPLA to put an invitational meet on the lifting calendar. The sanctioning fee is due by the first Friday in December. Member schools hosting dual meets must pay the requisite \$100.00 sanctioning fee at least two calendar weeks before the dual meet is contested.

- c) Shall comply with the recommended meet set-up and clerical standards set forth in Article XI, Section 11.11 of the LHSPLA Constitution.
- d) Shall charge a large enough entry fee to cover the costs of paying all meet Officials. Meet officials shall be paid in a timely manner. Timely matter is defined as payment within one calendar week of the meet date. Failure by a host school to pay meet officials within one week after the completion of a sanctioned invitational meet shall result in said school being fined \$250.00. The fined school will not be allowed to host another sanctioned invitational meet until the fine is paid in full to the LHSPLA. (Section 8.08 of Article VIII, LHSPLA Constitution)
- e) Shall provide that the invitational/dual meet site will serve as a certification venue for new officials.
- f) Shall provide copies/or place on file with the LHSPLA documentation (Certificate of Insurance naming the LHSPLA, the event, use of rented LHSPLA combo racks (if applicable) and/or officials as additional insured on host school's liability policy) of their school's or school boards liability insurance policy that will cover the invitational dual meet along with LHSPLA's and LHSAA's liability insurance coverage.
- g) Shall forward the results of said invitational/dual meet to the President of the association for him to distribute to the membership.
- h) Any member school(s) that chooses to host or participate in a **non-sanctioned** invitational or dual meet shall be fined \$500.00. Members schools affected will not be allowed to participate at the Regional Level until the fine is paid in full.
